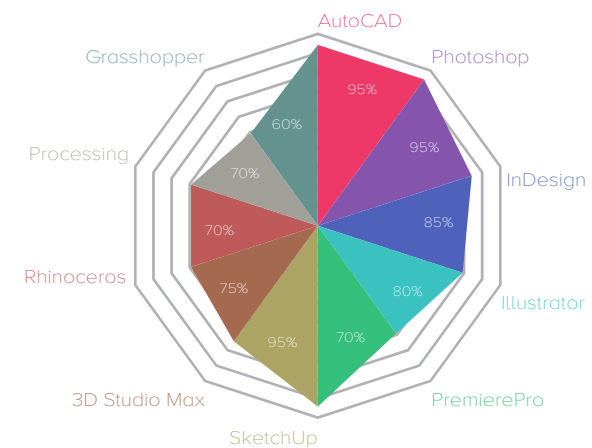

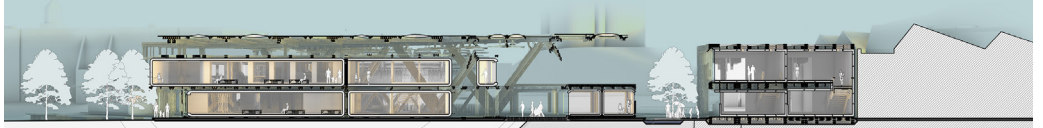
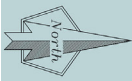

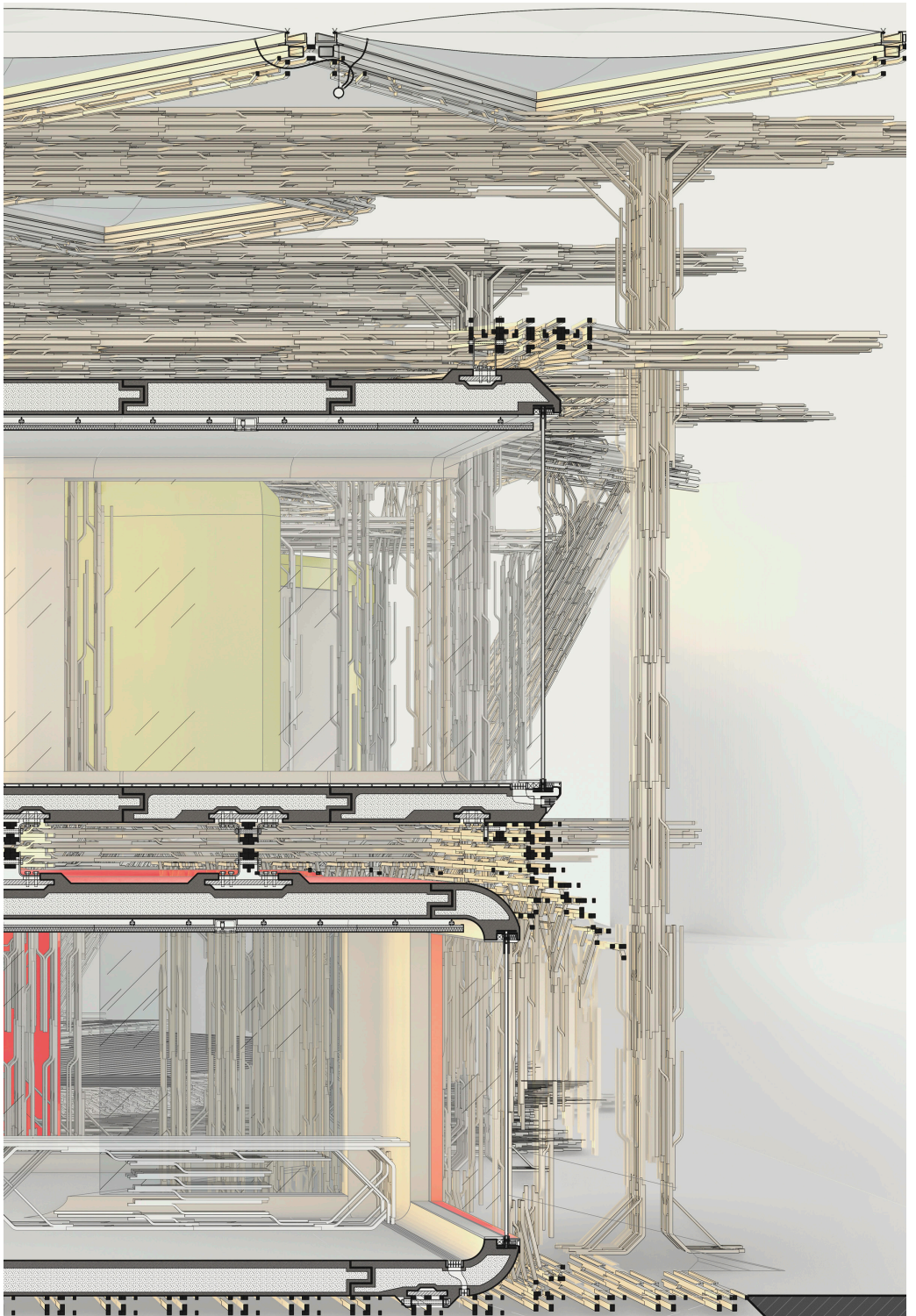

We can confirm that Jeremy Ivan Paton, resident at 28 Stonebridge Road, Canterbury, CT2 7LN has been employed by Clague LLP at our Canterbury office since 3rd April 2015. He is currently scheduled to leave the practice on 29th July 2016 in preparation for his return to university to undertake his Part II architectural studies and so will have gained 15 months experience.

This experience has mostly been focused on residential projects of varying scale and complexity with small scale commercial units where the project had a mixed use and including work on Extra Care units. Jeremy has worked within the master planning team which has seen him working on projects from 6 houses up to 270 houses both in countryside settings and within established towns in Kent and Essex. Within this period he has also worked on smaller scale residential projects including house extensions and alterations.

Jeremy's role within the team has been to work on all levels of drawings and schedules required to prepare projects for a Planning Application submission. This includes precedents studies, concept sketches, constraints and opportunities diagrams, site analysis, masterplan layouts, street scenes and unit type designs along with the production of accommodation schedules and Design and Access Statements. Jeremy has been involved in and contributed to initial discussions about design concepts for site layouts and has produced quick hand sketches to work through designs for unit type elevations and floor plans. Jeremy has been to site to see an earlier project, on which he has worked on the second phase, being constructed which has given him an incite into how the decisions made at planning stage effect how the final scheme will look both internally and externally.

Whilst working on projects Jeremy has dealt directly with other consultants and clients and has gained an insight into the processes and procedures that are involved with submitting a planning application. He has worked on the production of drawings for building regulation approval/construction for a smaller project in Sandwich which saw a house largely remodelled through extensive alteration and extensions. The planning process for this project was particularly drawn out and contentious and Jeremy was involved in reconciling the Planning Case Officer's comments and client's wishes and still trying to create a coherent design which retained the spirit of the original design.

Overall Jeremy has contributed a great deal to the team providing his thoughts on designs produced within the office, executing the work with precision and an eye for detail.
